### LCYC CODE OF CONDUCT AGREEMENT

The LCYC code of conduct exists to ensure the safety of the youth first and foremost. The staff and volunteers all strive to make LCYC an inclusive, safe and fun environment for everyone.

To be simple our code of conduct is RESPECT YOURSELF, OTHERS and the PROPERTY.

Respect is "a feeling or understanding that someone or something is important, serious, and should be treated in a human and appropriate way".

### Three strikes/warnings and you are asked to leave

We want to create and maintain an atmosphere of safety for youth, while are in operation. Hence, we follow a three warning system, where a youth will be given three strikes to correct their behavior/ action according to the rules listed below; if such behavior/ action continue, the youth will be asked to leave the Centre for the night (or longer based on staff decision).

#### **Tobacco & Vaporizers**

Youth need to ask for permission to take a smoke break. If youth leave designated smoking area, they are considered signing out. There is a zero tolerance for tobacco use and vaporizing on property.

#### Drugs/Alcohol

Any and all alcohol/drugs are not permitted for use at the Lloydminster Community Youth Centre. If youth have possession or are expected to be intoxicated staff/volunteers have the right to remove the youth for the night(s).

#### Fighting/Bullying/Aggressive Behavior

Pushing and shoving and calling someone on will not be tolerated. One warning will be given and if the behavior continues they will be asked to leave. Youth involved in serious fights will be asked for leave for a minimum of one week. We will keep a formal record of the incident.

#### Weapons

There is zero tolerance for an obvious use of a weapon, either threatening or attempt to use. If necessary, the police will be contacted to deal with the situation.

#### Language

All language should be inclusive and appropriate for everyone at LCYC. We ask that youth do not call each other down. If caught swearing or using bad language the "three warnings and you are out" rule will apply with language.

#### **Public Display of Affection**

Youth and leaders are uncomfortable if others are intruding on their personal space. The following is not permitted: laying down on another youth, groping, kissing, sitting down on another youth, etc. Staff have the right to make the judgement call on this matter.

#### **Food/Drinks Policy**

LCYC provides youth with a concession that includes chocolate bars, pop, candy, frozen treats, chips, and healthy alternatives. Energy drinks are not permitted in LCYC.

#### Signing In/Signing Out

All youth must sign in when they arrive and sign out when they leave.. If you leave the centre after 7pm you will NOT be allowed back in that night. On Wednesdays, Thursdays & Fridays you are allowed to leave only once before 7pm.
